#### **INFORMATIONAL ITEMS**

- 1) Fee Accountant suggested I pay the Auditors, because I signed a document after the audit was complete, so I could get the auditors reports. She felt the document held me to the higher dollar amount.
- 2) Installed Commercial Vinyl Plank flooring in apartment 307 at the Manor. This is the third completed apartment. Leon Country Floors were low quote.
- 3) Spectrum internet contract was signed. Internet coverage for those interested will begin February 1, 2024.
- 4) TDS installed fiber outside the grounds at the Lakeside Apartments.
- 5) A meeting was held between the City and Housing Staff to discuss the office lease agreement.
- 6) Due to low occupancy in 2022 at the Lakeside Facility, TPHA received a substandard rating within the HUD Public Housing Assessment System (PHAS), so I have been placed on a performance improvement plan.
- 7) Current occupancy:
  - (1) Manor 39/40 97%
  - (2) Maple Grove 2/2 100%
  - (3) Waterman 3/3 100%
  - (4) Lakeside 25/28 89% below standard, however 3 apartments offline for repairs (Unit 6, 10 and 12) Offline apartments not counted in HUD calculation, so 100%
