- 2) Motion by Komiskey, second by Thompson, to approve the minutes of the previous meeting as presented. All ayes. Motion carried.

Subject to a 20 feet wide storm water and utility easement, the centerline of which is described as follows: Beginning at the Southeast corner of said Lot 3; thence N61°20'55"W, a distance of 187.30 feet to the north line of said Lot 3, being the end of said line being described, also subject to a 20 feet wide utility easement along that part of said Lot 3 adjoining Interstate Highway "90". Also subject to all easements and right-of-ways of record. All ayes. Motion carried.
